- Copy of the mare's registration papers

ALL FEES must be paid in full before the shipment will be sent.

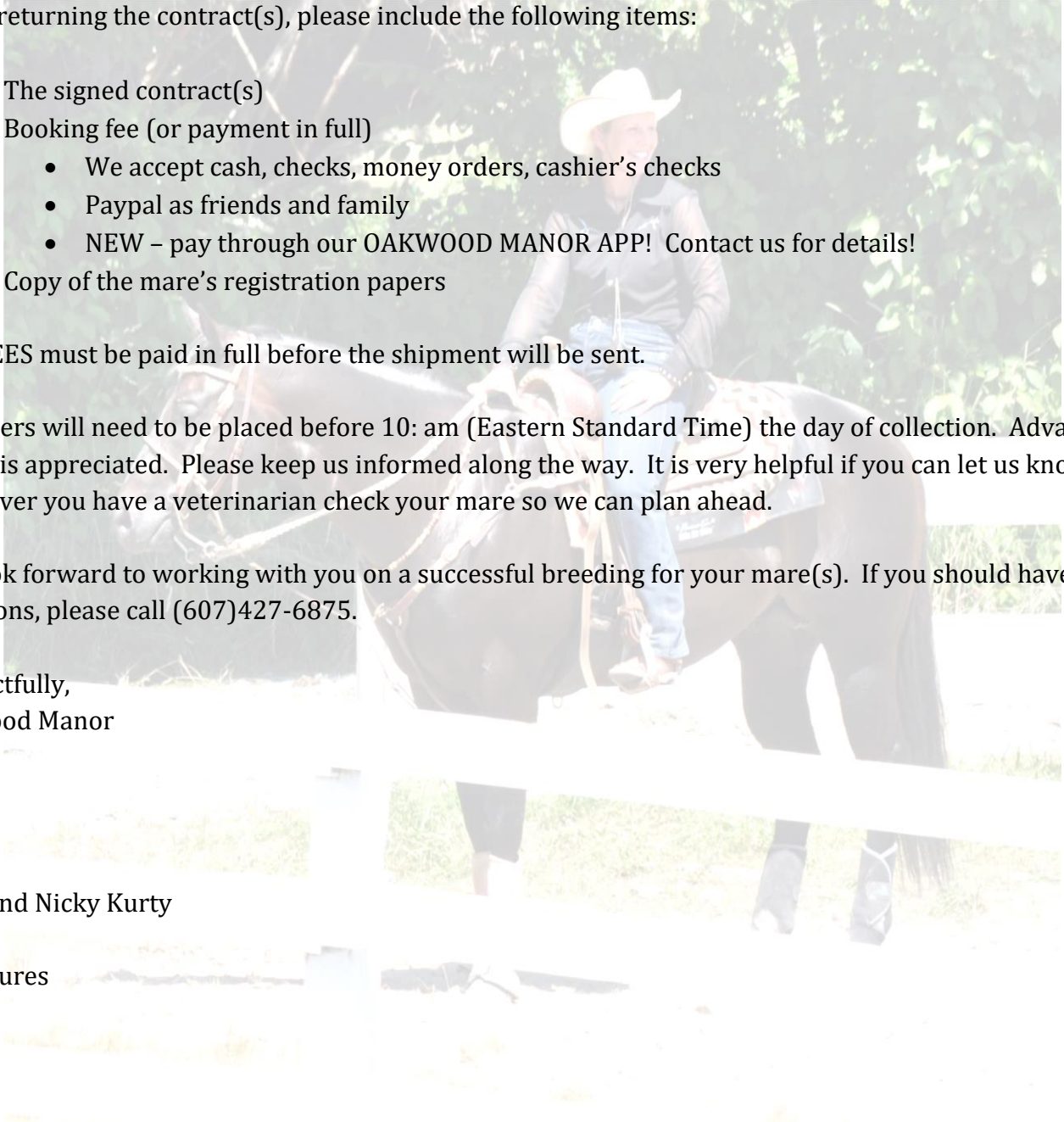

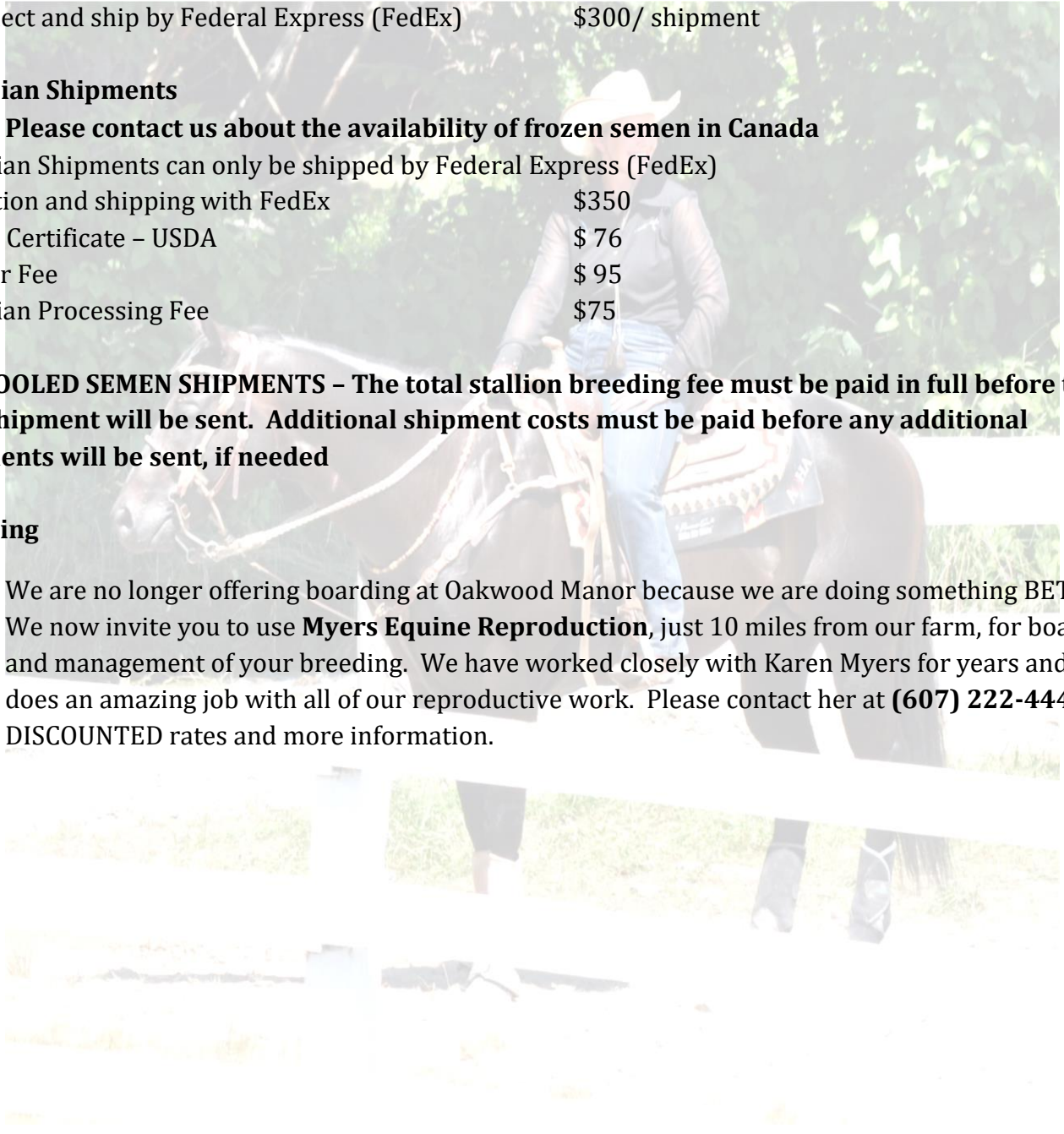

Mare owner will pay a stallion service fee of \$1150. A nonrefundable booking fee of \$250 is payable with this contract and reserves for the mare owner a shipped semen breeding for said season. Semen will not be shipped prior to payment of the booking fee and balance of the stallion service fee as well as the collection fee. We utilize Federal Express Priority Overnight Procedures. Fee for each collection is \$300 per shipment. Should you need Fedex FIRST overnight it can be provided for an additional fee. We accept cash, checks, money orders/cashier's checks. Paypal and credit cards accepted for 5% fee.

1. The mare must be healthy and in sound breeding condition. A copy of the mare's registration papers must be included with this contract.
2. This contract provides for a return breeding for said mare (or an agreed upon substitute) should she fail to produce a live foal. This may be satisfied at the sole option of Oakwood Manor by 1) shipped semen or 2) Oakwood Manor may require that the rebreeding be performed at Myers Reproduction or Cornell University or by 3) refunding the Stallion Service Fee less the booking fee. In the event no live foal is produced, we must be notified in writing within 10 days including a veterinary certificate.
3. Mare owner agrees to use the shipped semen to breed only the designated mare in accordance with this contract and registry rules.
4. Should the stallion die or become unfit for service this contract becomes null and void and any money paid as part of the stallion service fee (minus booking fee) will be refunded.
5. When mare owner signs and returns this contract it becomes a binding contract on both parties subject to the above terms and conditions. This contract is not transferable or assignable. Mare owner irrevocably agrees that his/her sole recourse against Oakwood Manor with respect to the performance or non-performance of this contract is a return of the stallion service fee less the booking fee.
6. Mare owner agrees to pay all court costs, including reasonable attorney fees, if any legal action is required to enforce any provision hereof.
7. The terms of this contract shall be governed by the state of New York.
